



2026 – 2027 PARKING PERMIT PACKET

ALL STUDENT FEES MUST BE PAID IN FULL IN ORDER TO PURCHASE A PARKING PASS.

The dates below are for all parking-related items for the 2026-2027 school year – **ALL APPLICATIONS WILL REQUIRE A PHOTOCOPY OF THE FOLLOWING ITEMS:**

1. Valid Arizona Driver's License (no permits)
2. Current Insurance Card for EACH VEHICLE – must be valid for at least 3 months
3. Current Vehicle Registration for EACH VEHICLE
4. Payment of \$60.00 – accepted payments: cash, debit/credit card, tap, or check (made out to "VVHS")

All Parking Permits are sold at the VVHS Bookstore only and are not available online. All permits will be ASSIGNED to students on a first-come, first-served basis on the dates listed below. All VVHS student parking will be in the back lot only – gates will open 5 minutes before the bell for late start students.

Parking spaces will be available for eligible seniors, juniors, and sophomores on the dates listed below, based on availability. If parking spots sell out a waiting list will be started.

JUNIORS (<i>seniors continue to purchase</i>)	Weds July 22 from 7am - 11am
SOPHOMORES (<i>seniors & juniors continue to purchase</i>)	Thurs July 23 from 7am - 11am
Per DUSD, VVHS will be closed on Friday July 24, 2026. Beginning August 6, 2026 parking passes may be purchased during student bookstore hours. If parking spots are sold out a waiting list will be created.	

All applicants must be on track with credits to meet their 2026-27 cohort requirements prior to applying for a pass. Student Automobile Use and Parking: Refer to DUSD Student & Parent Handbook and Dysart Board Policy 10.59.

PLEASE NOTE:

- Any outstanding student fees (*including elementary & middle school*) MUST be paid prior to purchasing a parking permit. Questions about fees should be directed to the specific school if not a VVHS fee.
- Payments can be made via cash, debit/credit, Tap, or check (*made out to "VVHS"*).
- We cannot take any payments over the phone and passes are not sold online.
- Completed applications must be submitted/accepted prior to payment. Parking is only allowed in your designated spot.
- ALL 3 ITEMS + PAYMENT MUST BE PRESENT FOR APPLICATION TO BE COMPLETE. INCOMPLETE PACKETS WILL NOT BE ACCEPTED AND SPACES CANNOT BE HELD.

THERE ARE NO REFUNDS ON PARKING PASSES ONCE PURCHASED.

VALLEY VISTA HIGH SCHOOL – 2026/27 STUDENT PARKING REGULATIONS

1. Once a parking permit/pass is issued there are no refunds, no exceptions.
2. All VVHS students must park in the student lot only.
3. Students will be assigned a numbered parking space that matches their parking permit/pass.
4. **PARKING PERMITS MUST BE PROPERLY DISPLAYED IN THE VEHICLE IT WAS ASSIGNED TO.**
Displaying a permit other than the one assigned may result in suspension or revocation of parking privileges.
5. **If another vehicle is parked in your assigned space, you must take a picture of the back of the car with the license plate number and send it to the posted QR code. You will only then be allowed to park in a student carpool space for that day. If the QR code does not work you must speak with Security immediately with the other car information.**
6. PARKING IN A NON-STUDENT PARKING SPACE WILL RESULT IN BEING BOOTED – this includes staff, maintenance, and visitor spaces.
7. A student may not give, sell, trade, or loan their assigned parking space/parking permit to another student, including family. This will result in the loss of both students' parking privileges.
8. **When an alternate vehicle not on file is driven to school, the student must EMAIL the bookstore at vvhs.bookstore@dysart.org with the car description & license plate information immediately. Failure to do so may result in suspension of parking privileges.**
9. There are no replacements for a lost parking tag unless a police report has been filed on the vehicle. You will have to purchase a new parking pass if lost.
10. Student parking lot hours are between 6:30am and 4:00pm. No loitering in the parking lots.
11. Unsafe driving practices on school property will result in suspension or revocation of parking privileges.
12. Students MUST follow proper sign-out procedures when leaving early. You will need to be signed out by a Parent/Guardian at the front office prior to exiting the lot. ***This excludes seniors who have early release***
13. Students MUST obtain permission from Administration BEFORE going to their vehicle during school operating hours.
14. No derogatory stickers, drawings, or writing are allowed to be displayed on vehicles – Ex: 187, 602, silhouettes of naked women, symbols of alcohol products, drugs, weapons, obscene language, etc.
15. Searches of vehicles will take place whenever a school official has reasonable suspicion to believe that illegal items, illegal drugs, alcohol, weapons or unauthorized persons, etc are contained within the vehicle.
16. ALL ACCIDENTS IN THE PARKING LOT MUST BE REPORTED IMMEDIATELY TO SECURITY AND AN INCIDENT REPORT MUST BE FILED.
17. PARK AT YOUR OWN RISK – VVHS and/or its personnel are not responsible for personal property, theft, loss or damage to vehicles and property.

18. If parking privileges are revoked, no refund will be issued.

19. Students are not allowed to park in Carpool Spaces.

20. If a handicap parking space is needed, please provide documentation to the nurse & front office.
In the event that any of the above-mentioned guidelines are not followed, your vehicle may be towed away at your expense. Furthermore, upon a determination by security or administration, your parking privileges may be revoked with no refund issued.

1st Violation:	ticket / warning
2nd Violation:	vehicle will be booted
3rd Violation:	vehicle will be booted and loss of parking privileges (no refund)
<i>Loss of Parking Privileges: With Administration's permission you may be able to reapply to purchase a new parking pass the following semester if spots are still available.</i>

REASONS A STUDENT MAY LOSE PARKING PRIVILEGES:

- 1. Failure to abide by the parking regulations as previously outlined.**
- 2. Driving recklessly and/or in an unsafe manner.**
- 3. Excessive speed.**
- 4. Excessive absences and tardy-abuse of the VVHS attendance policy.**
- 5. Repeated disciplinary incidences.**
- 6. Academic failure.**

In the event that any of the above-mentioned guidelines are not followed, your vehicle may be towed away at your expense. Furthermore, upon a determination by security or administration, your parking privileges may be revoked with no refund issued.
